## ARTICLES OF AMENDMENT TO \* ARTICLES OF INCORPORATION OF

#### Crossroads Christian School, Inc.

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment(s) adopted:

ARTICLE I NAME

Crossroads Christian Ministries, Inc.

#### ARTICLE III PURPOSE(S)

The purposes for which this Corporation is formed: to glorify God by fulfilling the Great Commandment (Matthew 22:36-40) and the Great Commission (Matthew 28:18-20); to share the good news of Jesus Christ with as many people as possible in our community and throughout the world (Matthew 28:18-20, Acts 1:8, 2 Peter 3:9); to help members develop toward full Christian maturity and train them for effective ministry, to promote personal, spiritual growth and discipleship through Bible teaching (Ephesians 4:11-13, Matthew 18:20, Timothy 2:2); to participate in worship services together in homes and in public; to maintain personal daily devotions (John 4:24); to serve unselfishly, in Jesus' name meeting the physical, emotional, and spiritual needs of those in our ministry, community and in the world (1 Peter 4:10-11, Matthew 25:34-40, 1 Thessalonians 5:11, Galatians 5:13); to promote, support, and provide Biblical and academic education to school age children; to ordain ministers of the gospel of Jesus Christ; to encourage, support and pray for each other as members of the family of God; to share our lives together (I John 1:7, Acts 2:44-47, Hebrews 10:23-25, Romans 15:5,7, John 13:34-35). This ministry seeks to benefit the people by providing opportunities for spiritual, physical, intellectual, social and cultural development, (Luke 2:52), and for such other lawful purposes as may be deemed appropriate to further the aforementioned purposes. To this end, the corporation shall at all times be operated exclusively for educational, charitable, and religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

#### ARTICLE XII STATEMENT OF FAITH

We believe in the one living, eternal God, Creator of all things, who exists in three persons: Father, Son, and Holy Spirit.

We believe the Bible is the inspired, infallible Word of God, and the supreme and final authority for all faith and conduct.

We believe by the miracle of the virgin birth that the Lord Jesus Christ, eternal Son of God, became man without ceasing to be God, in order to reveal God and to redeem man. That He died for our sins as a sacrifice and rose bodily from the dead for our justification. We believe He is now exalted at the right hand of God, that He is the Head of the Church, the Lord of the individual believer, that He is ministering as our Great High Priest and Advocate and that we are awaiting His bodily return.

We believe that man was created in the image of God but fell into sin and are therefore lost. And only those who become truly born again are saved from their sins.

We believe in the resurrection of both the saved and the lost, of the saved to eternal life with the Lord, and of the lost to eternal damnation.

We believe that as Christians we are called to live a godly life and are enabled to do that by the indwelling ministry of the Holy Spirit.

#### ARTICLE XIII AFFILIATION

This ministry is autonomous and maintains the right to govern its own affairs, independent of any denominational control.

#### ARTICLE XIV MEMBERSHIP

The basis upon which membership is determined shall be more fully set forth in the bylaws.

There are no members or members entitled to vote on the amendment. The amendments were adopted by the Board of Directors.
