The undersigned hereby submits these articles for the purpose of forming a corporation not for profit under Chapter 617, Florida Statutes, and certifies as follows:

ARTICLE I

Name

The name of the corporation shall be KINGS ISLAND XV CONDOMINIUM ASSOCIATION, INC., which corporation shall herein be referred to as the "Association", and whose principal place of business shall be c/o Mr. Ray Anderson, RAM Gulfcoast Corporation, 3245 Pine Ridge Road, Naples, Florida 34109.

ARTICLE II

Purpose

The purpose for which the corporation is organized is for the operation and management of condominium buildings and grounds for the use and benefit of the owners of the condominium units located in Charlotte County, Florida, known as KINGS ISLAND XV, A CONDOMINIUM, and any other purpose permitted under Florida Law.
