### ARTICLES OF INCORPORATION

OF

# BROWARD COUNTY MEDICAL ASSOCIATION CARE GROUP, WC

# A FLORIDA NONPROFIT CORPORATION

#### ARTICLE I

The name for this corporation shall be the Broward County Medical Association Care Group Inc.

#### ARTICLE II

The principal place of business and mailing address for the Corporation is 5101 N.W, 21st Avenue, Suite 440, Fort Lauderdale, Florida 33309.

### ARTICLE III

The purpose of the Corporation is as follows:

- A. This Corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purpose of this Corporation is the creation of a preferred provider network of medical care providers, services and facilities to provide medical care to qualified members of the Broward County Medical Association Physicians/Employees Provider Plan, a Florida Multiple Employer Welfare Arrangement.
- B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.
- C. Provided, however, that the Corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

#### ARTICLE IV

This Corporation shall have ten (10) Directors initially. The number of directors may be increased or diminished from time to time as provided in the Bylaws, but shall never be less than three (3). Directors shall be elected in the manner provided in the Corporation's Bylaws.
