ARTICLES OF INCORPORATION

OF

FIRST JERUSALEM COMMUNITY CHURCH, INC.

We, the undersigned, citizens of the state of Florida, pursuant to Chapter 617 Florida Statutes, have associated ourselves together, and do hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida as a corporation not for profit pursuant to the following Articles of Incorporation.

ARTICLE I - NAME

The name of the Corporation shall be FIRST JERUSALEM COMMUNITS CHURCH, INC. Fand it shall be hereinafter referred to as FIRST JERUSALEM COMMUNITY CHURCH, INC. Its principle office shall be, and is located in the City of Umatilla, County of Lake, and the State of Florida.

ARTICLE II - Physical And Mailing Address

The physical address of this corporation, in the name of First Jerusalem Community Church, Inc. is 38322 Jamestown Road, Umatilla, Florida 32784.

The mailing address of this corporation is P.O. Box 1347 Umatilla, Fl. 32784.

ARTICLE III - Purpose

The specific and primary purposes for which this corporation is formed are to operate for a place of religious and spiritual services for those residents and as well as visitors of this City, County, State, and from any other location of this United States Of America, through worship, fellowship, and membership.

The general purposes for which this corporation is formed are to operate exclusively for such purposes as will qualify it as an exempt organization under Section 501 (c) (3) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws, including for such purposes, the making of distribution to organizations which qualify it as tax-exemption organizations under that Code.

This corporation shall not, as a substantial part of its activities, carry on any propaganda or otherwise attempt to influence legislation, nor shall it participate or intervene (by publication or distribution of any statement, or otherwise) in any political campaign on behalf of any candidate for public office.

The general nature of the purpose of this corporation is to conduct for religious worship and instruct churches, schools, pastoriums, and other institutions that are connected therewith of a religious, educational, charitable and benevolent character to the end that its own members and others may be generally instructed and guided concerning those articles of faith which are most surely held among christian churches and to advance spirtual growth and enlightenment, moral and personal purity among its own membership and the people of the community in which it is located; to promote home and foreign missions; and to aid in the spread of the gospel of Jesus Christ to the ends of the earth also to educate, prepare, and ordain christian men and women for the ministery of the gospel of Jesus Christ. The purpose also includes the right to buy, rent, lease, sell, and own properties and institutions to accomplish the above-stated purpose.

ARTICLE -IV- Election And Appointing Of Director's

The affairs of this corporation shall be managed by a General Board of Trustees, such management to be subject to the approval of the church, and said General Board of Trustees shall be elected from and by the membership of said corporation. The term of membership of Trustees shall be for life, or for such other length of time, not less than one year, as the membership of said corporation may provide in its By-Laws. The said General Board of Trustees shall appoint from its own membership a Chairman, Vice-Chairman and Secretary. All legal instruments of the corporation shall be signed by said Chairman, sealed with the corporation seal and attested by said Secretary; or in such other manner as may be authorized by law. All elections to the membership of said General Board of Trustees shall be by a 2/3 majority vote of the members of the corporation present at any business meeting of the said corporation.

ARTICLE-V- Registered Agent

The name of the registered agent for FIRST JERUSALEM COMMUNITY CHURCH, INC., is Gregory Ogiste Sr. and his street address is as we know it to be, 1136 Mill Run Circle Apopka, Fl. 32703.

Gregory Ogiste, Sr., accepts the sesponsibilities of Registered Agent.

ARTICLE-VI- INCORPORATORS

This corporation shall have a President, Vice-President, Secretary, and Treasurer and such other officers as may be necessary, and such other officers shall be elected by a 2/3 majority vote of the corporation present at any business meeting of said corporation for such term as the corporation may provide by its By-Laws.
