ARTICLES OF INCORPORATION OF ST. AUGUSTINE PRIORY, INC.

A NON-PROFIT CORPORATION

We, the undersigned, natural persons over the age of twenty-one (21), acting as incorporators of a corporation not for profit under the authority of Section 617.0202, Florida Statutes, and the Non-profit Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I

The name of this corporation shall be ST. AUGUSTINE PRIORY, INC. Its business shall be carried on at Miami, Miami-Dade County, Florida and at such other places in the United States of America as may, from time to time, be authorized by the Board of Directors.

ARTICLE II

The principal place of business and mailing address of this corporation shall be: 1938 SW 6th St. Miami, FL 33135-3208.

ARTICLE III

The general purpose of this corporation shall be to provide a residence where clergy and lay members of St. Augustine Priory may live and worship according to the Western Rite of the Holy Orthodox Catholic and Apostolic Church.

ARTICLE IV

The manner in which the directors are appointed is by election of the Board of Directors at the Annual meeting. A majority vote shall be required and the President shall have a veto power.

ARTICLE V

The name and Florida street address of the initial registered agent are: Canon MICHAEL F. LOBO

ARTICLE VI

The initial officers of this corporation shall be:

\*\*Their mailing addresses will be that of the Principal office.

ARTICLE VII

In case of dissolution of this corporation, its assets shall go to The Shrine of Our Lady of Regla, a church with which St. Augustine Priory is affiliated.

ARTICLE VIII

The effective date of incorporation of St. Augustine Priory, Inc. shall be May 4, 1998.

ARTICLE IX

The provisions of this Charter, and each and every article and section hereof, and the By-laws of this corporation, shall be considered a part of every contract and transaction to which this corporation shall be a party.
