ARTICLES OF AMENDMENT TO AMENDED AND RESTATED  
ARTICLES OF INCORPORATION  
OF  
FAITH CHRISTIAN CENTER CHURCH, INC.

Pursuant to Section 617.1006, of the Florida Not For Profit Corporation Act, FAITH CHRISTIAN CENTER CHURCH, INC., a Florida non-profit corporation (the "Corporation"), does hereby amend its Amended and Restated Articles of Incorporation as follows:

1. Article IV of the Amended and Restated Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:

ARTICLE IV -- PURPOSE

The corporation is organized as a corporation not for profit, exclusively for charitable, religious, educational, and scientific purposes within the meaning of Section 510(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, including, but not limited to, the operation of a church and all activities incidental or related thereto. Key missions of the church include (i) fostering affordable, low income housing and (ii) facilitating quality education.

The foregoing Articles of Amendment to Amended and Restated Articles of Incorporation were adopted and approved by the Board of Trustees of the Corporation on August 14, 2009.

There are no members of the Corporation entitled to vote on such Articles of Amendment to Amended and Restated Articles of Incorporation.
