ARTICLES OF AMENDMENT  
TO  
AMENDED AND RESTATED ARTICLES OF INCORPORATION  
OF  
FAITH CHRISTIAN CENTER CHURCH, INC.

Pursuant to the provisions of Section 617, Florida Statutes, FAITH CHRISTIAN CENTER CHURCH, INC., a Florida non profit corporation (the "Corporation"), adopts the following Articles of Amendment to Amended and Restated Articles of Incorporation:

1. The name of the Corporation is FAITH CHRISTIAN CENTER CHURCH, INC.
2. The effective date of this amendment shall be April 20, 2014.
3. Article I of the Amended and Restated Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:

"ARTICLE I.  
NAME

The name of the corporation is IMPACT CHURCH OF JACKSONVILLE, INC."
