

2. All assets held by the Association upon condition requiring return, transfer or conveyance, which condition occurs by reason of the dissolution, shall be returned, transferred or conveyed in accordance with such requirements.
3. Assets received and held by the Association subject to limitations permitting their use only for charitable, religious, eleemosynary, benevolent, educational or similar purposes, but not held upon a condition requiring return, transfer or conveyance by reason of the dissolution shall be transferred or conveyed to one or more domestic or foreign corporations, trusts, societies or organizations engaged in activities substantially similar to those of the dissolving Association.
4. Pursuant to Section 14.2 of the Articles of Incorporation, all remaining assets shall be dedicated to Pebblebrooke Lakes Master Association, Inc., a Florida not-for-profit corporation.


WHEREAS, at least two-thirds (2/3) of the Members entitled to vote on the recommendation voted in favor of such dissolution.

NOW, THEREFORE, BE IT RESOLVED that the Association shall be dissolved pursuant to Florida Statutes Chapter 617.1403; and be it further


