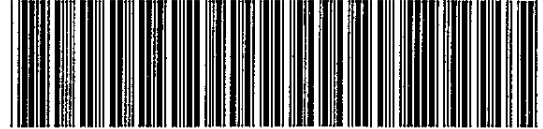

SUNCOAST TECHNOLOGY ALLIANCE, INC., (the "Corporation"), a corporation not for profit organized and existing under the laws of the State of Florida, in order to amend its Articles of Incorporation in accordance with the requirements of Chapter 617, Florida Statutes, does hereby certify as follows:

1. The Articles of Incorporation of the Corporation were filed with the Secretary of State of the State of Florida on the 13th day of May, 1998, under the name "SUNCOAST TECHNOLOGY ALLIANCE, INC."
2. The amendment to the existing Articles of Incorporation being affected hereby is a change in the name and address of the corporation as set forth below.
3. In accordance with Florida Statutes §617.1002, these Articles of Amendment were unanimously approved and adopted by resolution at a special meeting of the board of directors of the Corporation on the 25th day of April, 2005. Furthermore, no member(s) of the corporation are entitled to vote on the aforementioned amendment.
4. After payment of all required taxes and fees, these Articles of Amendment are to be effective immediately upon filing with the Secretary of State of the State of Florida, at which time the existing Article I of the Articles of Incorporation of the Corporation shall be deleted in its entirety and the following Article I shall be substituted in its place and stead:

“ARTICLE I
