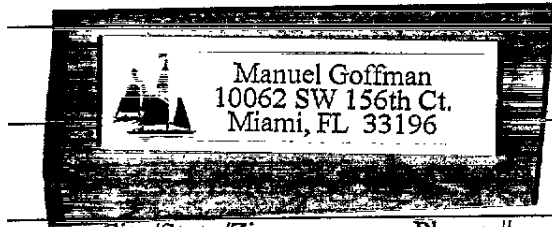


ARTICLE VIII - MEMBERSHIP



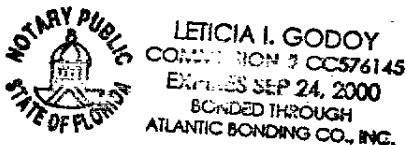
