First: The name of the corporation is Christian Community Ministry Jesus the Fountain of the Life, Inc.

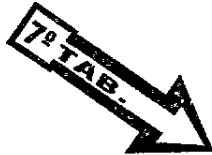
Second: Adoption of dissolution.

 Miami, November 20, 2000


