ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be: EVANGELICAL MARANATHA, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: P.O. Box 490643, Ft. Lauderdale, Florida 33349-0643.

ARTICLE III - PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are): General worship services, Christian Education, Sunday School, Youth Fellowship, Weekly Bible Studies, Ordination and Installation of Ministries, Baptism in water, Visiting the sick in hospital ministry, visiting the incarcerated jail ministry, Orphanage, Children presentation and Domicile service.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows: Elections shall be made by majority vote of the Directors. This provision may be ratified by new laws adapted by the Board of Directors.
