ARTICLES OF INCORPORATION
OF
RASTAFARI HEALTH SCIENCE, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be: RASTAFARI HEALTH SCIENCE, INC.
