The corporation shall consist of a community of those who suffer from and/or care about individuals with OCD and other bio-chemical disorders. The specific purposes for which this corporation is organized, is to: (1) insure all receive accurate information and awareness regarding Obsessive-Compulsive Disorder.

(2) provide support to those in the this area who are affected in any way by this disorder.

(3) provide outreach so that all those in need can obtain proper treatment.

(4) to assist in research for treatments and a cure for this illness in any way possible.

Article Four.

Each Director shall be elected at the Annual Meeting of the Board of Directors or to fill a vacancy at any regular meeting and shall hold office for the next two years, or until his/her resignation or removal. Nominations for the Board of Directors shall be made by the Board of Directors. Any or all of the Directors may be removed by the Board of Directors by a majority vote with or without cause.

No Director, other than one of the Founders, as hereafter defined, may serve more than three (3) consecutive terms as a Board member and shall not be eligible for re-election as a Director for a period of one year immediately following the expiration of such a third term. Founders shall be those persons who were original Directors of the Corporation at the time of its incorporation. Founders may continue to serve beyond three (3) consecutive terms and subject to the terms of these by-laws, until they shall resign from the Board.
