ARTICLES OF INCORPORATION

Of MCKEEL ACADEMY, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Article of Incorporation:

<u>ARTICLE I</u>

NAME

Section 1.1

The name of this not for profit corporation shall be:

ARTICLE III EFFECTIVE DATE

Section 3.1 The effective date of these Articles of Incorporation shall be the date these article are filed with the Secretary of State.

ARTICLE IV

- Section 4.1 The specific purpose for which the corporation is organized is to establish and operate a not for profit conversion charter school, which will be able to transact any and all business deemed lawful by the Florida Not for Profit Corporation Act, and to distribute the income therefrom exclusively for charitable, scientific, literary, or educational purposes, directly or by contribution.
- Section 4.2 This corporation shall issue no stock. No part of its earnings shall be distributed to its members, directors, or other private persons, except that this corporation shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in accordance with the purpose set forth in Section 3.1 of these articles.

ARTICLE V MANNER OF ELECTION OF DIRECTORS

Section 5.1 The Founding Executive Board of Directors shall be appointed by the principal of McKeel Academy, Inc., and shall serve from time to time. The principal of McKeel Academy, Inc. shall hold a non-voting seat on the Board. The Founding Board of Directors shall serve a minimum of (6) months and no more than three years. When a Director is replaced, the Principal will recommend three names to the Board of Directors. The Board will vote the new elect by majority Director. In case of a tie, the Principal will cast the deciding vote.
