

- FIRST ARTICLES OF AMENDMENT OF KIDS LIVING WITH AIDS, INC.,

 A FLORIDA NONPROFIT CORPORATION

 AM 9: 25 NonProfit Corporation.
 - 2. The following is added to Article 3, subparagraph (a):

Said corporation is organized exclusively for charitable, educational, religious or scientific purposes, within the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding section of any further federal tax code).

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carry on by a) a corporation exempted from federal income tax under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future federal tax code).

Upon dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, i.e. charitable, educational, religious, or scientific, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose.

However, if named is not then in existence or no longer a qualified distributee, or unwilling or unable to accept the distributions, then the assets of this corporation shall be distributed to a fund, foundation or organization organized and operated exclusively for the purposes specified in Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future federal tax code).

3. This Amendment was adopted by the Board of Directors on January 3.

2000 and there are no members entitled to vote on the Amendment.

4. This Amendment was approved by the Board of Directors of the corporation at a meeting held for that purpose held on January 3, 2000. At said meeting, the Board of Directors voted unanimously for the approval of this Amendment.
