

ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be:

ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are);

- ◆ To advocate and educate for efficient and effective county health and human service programs.
- ◆ To ensure that the diversity of the membership counties is acknowledged and supported through FACSSE communications, deliberations and actions.
- ◆ To provide a forum to facilitate networking.
- ◆ To provide a process to facilitate technical consultation.
- ◆ To promote and influence legislation on the local, state, and national level.
- ◆ To inform the public and elected officials about the roles and responsibilities of human service programs.
- ◆ To promote FACSSE as a valuable resource.

Whereas FACSSE is an association of social and human service program managers counties employed in the State of Florida; and






Whereas the Florida Association of Counties, Inc., (FAC) is an association composed of county commissioners, many of whom employ these social and human service program managers; and


