ARTICLES OF INCORPORATION
OF
SRIGANDHA KANNADA KOOTA OF FLORIDA, INC.

ARTICLE I. - NAME

The name of this corporation is **SRIGANDHA KANNADA KOOTA OF FLORIDA, INC.**

ARTICLE II. - PURPOSE

This corporation is organized under the not for profit corporation laws of the State of Florida, is a secular, non-political, not for profit, charitable, cultural and educational organization to provide a common platform to the various Kannada Kootas in the United States of America and in Canada, and any other organizations formed to the furtherance of Kannada culture to coordinate cultural, educational, social economic and community affairs of the people of Indian origin in North America.

The Association will make no distribution of income to its members.

ARTICLE III. - EXISTENCE & COMMENCEMENT

This corporation shall have perpetual existence and its existence shall commence upon the filing of these Articles.

ARTICLE IV. - PRINCIPAL OFFICE

ARTICLE V. - REGISTERED AGENT & ADDRESS

The affairs of the Corporation will be managed by a Board of Directors. The number of members of the Board of Directors will be determined by the bylaws of the corporation but shall not be less than three. The method of election of the directors shall be as provided in the bylaws of the corporation.

ARTICLE VIII. - INDEMNITY OF OFFICERS & DIRECTORS


The corporation shall indemnify any officer or director to the full extent permitted by law.


