ARTICLES OF INCORPORATION OF TRUTH WORSHIP CENTER, INC.

The undersigned, for the purpose of forming a nonprofit corporation under Florida Statutes Chapter 517, do hereby make and adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is TRUTH WORSHIP CENTER. INC.

ARTICLE II. NOT FOR PROFIT

The Corporation is a nonprofit corporation under the laws of the State of Florida. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its Members, Director or Officers, except to the extent permissible under law.

ARTICLE III. DURATION

The period of the corporation's duration shall be perpetual unless dissolved according to law.

ARTICLE IV. PURPOSE

The general purposes for which the corporation is organized are:

- 1. Charitable and educational within the meaning of section 501(c)(3) and 509(a) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- 2. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) and 509(a) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- 3. To promote and establish a place of worship, to promote, foster and create Christian organizations

who provide counseling, housing, food, clothing for those in need more specifically battered and/or abused children, shelters for battered and/or abused women, day care programs for children, create youth and drugs programs and any other programs necessary to serve the community.

- 4. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations, including without limiting the generality of the foregoing, to acquire by bequest, devise, gift, purchase, lease or otherwise any property of any sort or nature without limitation as to amount or value, and to hold, invest, re-invest, manage, use, apply, employ, sell, expend, disburse, lease, mortgage, convey, option, donate or otherwise dispose of such property and the income, principal and proceeds of such property, for any of the purposes set forth herein.
- 5. To do such other things as are incidental to the purpose of the Corporation or necessary or desirable in order to accomplish them.

ARTICLE V. LIMITATION

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its Members, Director or Officers, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV (Purposes) hereof.

ARTICLE VI. MEMBERS

The Corporation shall have Voting Members who shall be elected (and may be removed) by the Voting Members and shall have all the rights and privileges of members of the Corporation. The Bylaws may provide for Nonvoting Members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the Bylaws, but who shall not have the right to vote. ARTICLE VII. INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VIII. INITIAL BOARD OF DIRECTORS

The Bylaws may provide for ex-official and honorary Director, and their rights and privileges.

ARTICLE IX. OFFICERS
