The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a cooperative pursuant to Chapter 618 of the Florida Statutes.

ARTICLE I. NAME

The name of this cooperative is: The Ridge Irrigation Cooperative

ARTICLE II. COOPERATIVE PURPOSE

This corporation is being formed for the purpose of operating a well and distribution mains for use in the production of citrus on a non-profit cooperative basis.

ARTICLE III. CAPITAL STOCK

This corporation shall have one class of stock with unlimited voting rights and the right to receive the net assets of the corporation upon dissolution. The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 10,000 shares of common stock with no par value.
