

# ARTICLES OF INCORPORATION OF



### SOUTH LAKE COUNTY HISTORICAL SOCIETY, INC.

### A Florida Corporation Not For Profit

The undersigned, for the purpose of forming a corporation under the Florida Not-For-Profit Corporation Act, do hereby adopt the following Articles of Incorporation:

# Article One Name & Address

The name of the Corporation is **SOUTH LAKE COUNTY HISTORICAL SOCIETY**, **INC.**, with a principal office address of 24 Emerald Lakes, Clermont, Florida 34711.

### Article Two Duration

The term of existence of this Corporation is perpetual.

#### Article Three Purpose

This Corporation is organized exclusively for charitable or educational purposes. It shall promote and encourage historical research; to acquire, by purchase, gift, devise, or otherwise, the title to, or the custody and control of, historic locations and structures; to preserve and protect buildings and sites of historic interest; to collect and preserve records, relics, and other things of historic interest; to mark places of historic interest with suitable monuments and markers; to foster and promote public knowledge of and interest in local and national history. Notwithstanding any other provisions of these Articles, these purposes are limited to those described in Section 501 (c)(3) of the Internal Revenue Code of 1954 or any other corresponding provision of any future United States Internal Revenue Code.

### Article Four No Private Benefit

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

# Article Five Directors

There shall be not less than five (5) nor more than eleven (11) persons on the Board of Directors of the Corporation, who shall be elected at the annual meeting of the membership. #### Article Six Officers

#### Article Seven Members

Members may be admitted to the Corporation by a majority vote of the Board of Directors upon qualifications prescribed by the By-Laws of this Corporation.

### Article Eight By-Laws

The By-Laws of the Corporation are to be made, altered, or rescinded by a majority of the Directors of the Corporation.

# Article Nine Amendments to Articles

These Articles of Incorporation may be amended by a majority vote of the Directors of the Corporation at any meeting of the Directors of he Corporation wherein a quorum is present (a quorum being at least one half of the Directors of the Corporation) with at least ten (10) days advance written notice of any such meeting having been given to all Directors of the Corporation.


### Article Eleven Dissolution

In the event of dissolution, the residual assets of this Corporation will be turned over to such organization or organizations as determined by the last Board of Directors hereof which themselves are exempt as organizations described in Section 501 (c)(3) and 170 (c)(2) of the Internal Revenue Code or corresponding section of any future tax code, or shall be distributed to the federal, state, or local government for an exclusively public purpose.

### Article Twelve Private Foundation Status

Notwithstanding anything to the contrary contained in these Articles, during any taxable year in which it is determined that the Corporation is a private foundation within the meaning of Section 509 of the Internal Revenue Code and the regulations thereunder,

- 1) The corporation will distribute its income for each tax year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Internal Revenue code, or corresponding section of any future federal tax code.
- 2) The corporation will not engage in any act of self-dealings as defined in Section 4941(d) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- 3) The corporation will not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- 4) The corporation will not make any investments in such manner as to subject it to tax under Section 4944 of the Internal Revenue Code, or corresponding section of any future federal tax code.
- 5) The corporation will not make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code, or corresponding section of any future federal tax code.



## Article Thirteen Office and Resident Agent of Corporation

This corporation shall maintain an office at 24 Emerald Lakes, Clermont, Florida 34711, with a resident agent thereat upon whom process may be served. Initial Resident Agent shall be **JAMES H. GRANT** who having been named as Resident Agent for this Corporation at the place designated as the office of the Corporation does hereby accept this appointment as Resident Agent and agrees to act in this capacity and agrees to comply with all of the provisions of Florida law relative to this capacity.
