ARTICLES OF AMENDMENT

OF,

LAKE FANTASIA HOMEOWNERS' ASSOCIATION, INC., a Florida not-for-profit corporation

On the day of August, 2000, the Lake Fantasia Properties, L.L.C., a Florida limited liability company, possessing more than seventy-five percent (75%) of votes of the membership of Lake Fantasia Homeowners' Association, Inc., took action pursuant to Chapter 617, Florida Statutes, requiring the Association to amend its Articles of Incorporation. Lake Fantasia Properties, L.L.C. has executed a written consent to the amendment at the end of this instrument. The Association, having received such consent, hereby adopts the following amendment:

The Articles of Incorporation are hereby amended as follows:

I. ARTICLE VI, Class B, first sentence is hereby deleted and replaced by the following:

"The Class B Member shall be the Developer, and shall be entitled to three (3) votes for each lot owned."

- II. ARTICLE VI, Class B.(a) is hereby deleted and replaced by the following:
- (a) three months after seventy-five percent (75%) of the lots have been conveyed to Class A members; or
- III. ARTICLE VI, Class B. is hereby deleted in its entirety and replaced by the following:
 - "Class B. The Class B member shall be the Developer, and shall be entitled to three (3) votes for each lot owned. The Class B membership shall cease and be converted to Class A and be converted to Class A membership on the happening of the following events, which ever occurs earlier:
- (a) three months after seventy-five percent (75%) of the lots have been conveyed to Class A members; or
- (b) on the anniversary date seven (7) years from the date when the first lot is conveyed to an individual purchaser; or
 - (c) at the election of Developer.
 - IV. The following ARTICLE XIV is hereby added:

ARTICLE XIV APPROVAL OF AMENDMENTS

"So long as there is a Class B Membership, if any mortgage encumbering any Unit is guaranteed or insured by the United States Department of Housing and Urban Development or by the Veterans Administration, then the following action made by Developer, or made by the Members, must be approved by both agencies: any annexation of additional properties; any merger, consolidation, or

dissolution of the Association; any mortgaging of any Common Area; and any amendment to the Articles or the By-Laws."
