ARTICLES OF INCORPORATION OF

Summerisle Spinners and Weavers, Inc. EIN: 65-0870949

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - Name

The name of the corporation shall be Summerisle Spinners and Weavers, Inc.

ARTICLE II -Principal Office

The principal place of business and mailing address of this corporation shall be:

ARTICLE III - Purpose

This corporation is formed exclusively to educate the public on the art, craft and history of spinning and weaving via public demonstration and lecture and to provide opportunities for the public to participate in the art and crafts of spinning and weaving, within the meaning of section 501(c)(3) of the Internal Revenue Code.

ARTICLE IV - Manner of Election of Directors

The corporation will have one director initially who shall hold office for the first year of the corporation, or until their a successor is appointed.

ARTICLE VII - Earnings of Corporation

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of The Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to wich are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VIII - Dissolution of Corporation

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
