The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE 1 - NAME

The name of the Corporation shall be The Future Artists Network for the Pinellas County Center for the Arts at Gibbs High School, Inc.

ARTICLE 3 - PURPOSES

The purpose of the Future Artistis Network of the Pinellas County Center for the Arts (PCCA) is to insure that the excellence, quality, and integrity of the PCCA program remains as originally intended and not jeopardized as a result of diminishing funds or financial constraints.

To this end, the mission of the Future Artists Network is to: (1) enhance the quality of student education by assuring optimum instructional resources for all students through a working partnership between parents, staff members and administration of Gibbs High School and the PCCA,

and the Pinellas County School Board; and (2) insure that the long-standing success of the PCCA program at Gibbs High School continues to promote the artistic development of those students dedicated to pursuing their education in the arts.

The Future Artists Network is dedicated to working with the Gibbs High School and PCCA administration and staff, Pinellas County School Board, and the community to develop additional resources in order to meet the staffing, services, materials, and other needs of the program as indicated by the program director in consultation with the PCCA faculty.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is:

- A. Individuals desiring to seek the office of President, Vice-President, Treasurer, or Secretary shall be members in good standing of the Future Artists Network.
- B. Nominations for the offices of President, Vice-President, Treasurer, and Secretary shall be taken at the regularly scheduled April meeting of the Future Artists Network.
- C. Elections for the offices of President, Vice-President, Treasurer, and Secretary shall be held at the regularly scheduled May meeting of the Future Artists Network.
- D. Officers shall serve a twelve (12) month of June through May.
- E. No individual shall serve more than two (2) consecutive terms in any office.
- F. Vacancies. Vacancies shall be filled by individuals nominated by the President of the Future Artists Network with the concurrence of those members present at the next regularly scheduled meeting of the Future Artists Network.

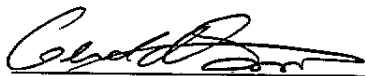

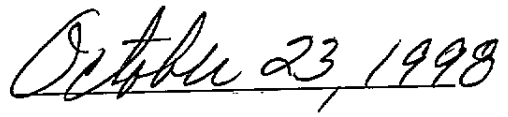
ARTICLE VII - EFFECTIVE DATE
