The undersigned, desiring to form a Corporation Not For Profit for the purposes hereinafter stated, under and pursuant to Chapter 617 of the Florida Statutes, do hereby declare as follows:

I. NAME

The name of the Corporation shall be SEPHARDIC SYNAGOGUE OF FORT LAUDERDALE- "BNM", INC.

II. NOT FOR PROFIT PURPOSE

The Corporation is being organized for the purpose of undertaking establishing a religious congregation for jewish individuals of sephardic background and for such other community activities not for profit, and such other permitted purposes. In furtherance of its corporate purpose, the Corporation shall have all general powers enumerated in Section 617.0302 of Florida Statutes, being the Not For Profit Corporation Law, as same may be amended.

III. PRINCIPAL OFFICE

The principal office and mailing address of the Corporation shall be located at P.O. Box 11739, Fort Lauderdale, Florida 33339.

IV. BOARD OF DIRECTORS
