ARTICLES OF AMENDMENT OF

T.E.A.M. MINISTRIES, INC., A Florida Corporation Not For Profit

Pursuant to Chapter 617 of the laws of the State of Florida, having been resolved by the Board of Directors of above-referenced Corporation, and being duly submitted to a vote at a meeting of board of directors and approved, T.E.A.M. MINISTRIES, INC., a Florida Corporation Not For Profit, and hereby adopts the following Articles Amending the Articles of Incorporation for the above-referenced Corporation:

Article III

The corporation is a not for profit corporation. The purpose for which the corporation is organized is to be a religious organization which provides the training to equip the followers of Jesus Christ to do the work of his ministry, including distributing funds it may generate for such purpose.

- (a) Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future United States Internal Revenue Law.
- (b) The general purposes for which this corporation is formed are to operate exclusively for such religious, charitable, and educational purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making of distributions to organizations which qualify as tax-exempt organizations under that Code.
- (c) This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

There is/are no voting members of T.E.A.M MINISTRIES, INC., who are or would be required to approve or disapprove any amendment to the Articles of Incorporation of the aforesaid corporation.

All directors of T.E.A.M. MINISTRIES, INC., a Florida Corporation Not For Profit, have approved this Amendment to the Articles of Incorporation of T.E.A.M. MINISTRIES,

INC., a Florida Corporation Not For Profit, after first having unanimously adopted and approved such amendment in lieu of a Special Meeting of Board of Directors, pursuant to 617.0823, Florida Statutes, effective the 15th day of April, 1999, an original signed consent in lieu of Special Meeting of said Board of Directors is attached hereto, and is hereby incorporated by reference as if fully set forth herein.
