ARTICLES OF AMENDMENT OF DEBARY UNIT 17 HOMEOWNERS ASSOCIATION, INC

The undersigned, as a Director and on behalf of the Board of Directors of DEBARY UNIT 17 HOMEOWNERS ASSOCIATION, INC., pursuant to §617.1002, <u>Fla. Stat.</u> (2004), submits and approves these Articles of Amendment and states as follows:

- I. The name of the corporation is DEBARY UNIT 17 HOMEOWNERS ASSOCIATION, INC.
 - 2. The text of the Articles of Amendment is as follows:
- A. Article L of the Articles of Incorporation for the corporation is hereby amended by deletion of the existing text, and substitution in its stead of the following text:
