ARTICLES OF AMENDMENT

The Articles of Incorporation of REMINGTON AT KINGS RIDGE NEIGHBORHOOD ASSOCIATION, INC., a Florida corporation, were filed with the Florida Secretary of State on December 4, 1998, under Document No. N98000006921.

1. The following provision of the Articles of Incorporation is hereby amended in the following particular:

Article I is hereby amended to read as follows:

"ARTICLE I

NAME

The name of the corporation is Remington at Kings Ridge Homeowners Association, Inc. For convenience, the corporation shall be referred to in this instrument as the "Association", these articles of incorporation as the "Articles", and the bylaws of the Association as the "Bylaws".

2. The foregoing amendment was adopted by the members and the directors of the corporation on the 18TH day of FEBRUARY, 1999.

3. The number of votes cast for the amendment by the members of the corporation was sufficient for approval.

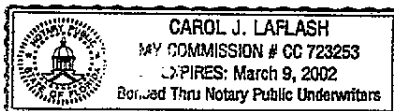
