ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
AWRJV OWNERS' ASSOCIATION, INC.

SECRETARY OF STATE  
TALLAHASSEE, FLORIDA

1. The following provisions of the Articles of Incorporation of AWRJV Owners' Association, Inc., a Florida not-for-profit corporation, filed in Tallahassee on December 11, 1998, are hereby amended as follows:

Article XIV is hereby amended to read in its entirety as follows:

DISSOLUTION OF THE ASSOCIATION.

14.1 Upon dissolution of the Association, all of its assets remaining after provision for creditors and payment of all costs and expenses of such dissolution shall be distributed in the following manner and order:

14.1.1 The easements as defined in the covenants shall be dedicated or conveyed to either a similar non-profit organization or to a municipal or other governmental authority and which the authority is willing to accept; but, in any event, to an organization which will assure continued maintenance and operation of the easements; and

14.1.2 The remaining assets shall be distributed among the Owners, as tenants in common, with each Owner's proportionate share of the assets determined in accordance with his proportionate share of the voting rights.

14.2 The Association may be dissolved upon a resolution to that effect being approved by all of the following: (a) two-thirds (2/3rds) of the Directors of the Board; (b) two-thirds (2/3rds) of the Owners; (c) the issuance thereafter of a decree of dissolution by a Circuit Judge as provided by Florida Statutes, as amended.

2. In all other respects, the Articles of Incorporation shall remain as they were prior to this Amendment being adopted.

3. The foregoing amendment was adopted by the Members and the Directors of the corporation on the 12<sup>th</sup> day of MAY, 2000.
