### ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617.0202, Florida Statutes, adopts the following Articles of Incorporation:

#### ARTICLE - I Name

### ARTICLE - VI Purpose(s)

This corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

As a means and incidental to accomplishing the purposes for which this corporation is being organized, it shall have the following powers: to accept, acquire, receive and hold by bequest, devise, grant, gift, purchase, exchange, lease, transfer or otherwise, for any of its objects and purposes, any property, whether real or personal, of whatever nature or description to be administered and disposed of in accordance with and pursuant to Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

### ARTICLE - VII Limitation of Corporate Powers

The powers of this corporation are as provided in Section 617.0302 of the Florida Statutes, unless limited. No part of the earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Sixth hereof. Not withstanding any other provision of these articles, this corporation shall not engage

in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

#### ARTICLE - VIII Distribution upon Dissolution

In the event of the partial or complete liquidation or the dissolution of the Corporation, the residual assets of the Corporation will be turned over to (a) one or more organizations which themselves are exempt as described in section 501(c)(3) of the Internal Revenue Code, or to (b) to any federal, state or local government for public purpose. Any assets not so disposed of, shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is located, exclusively for such purposes, or to such organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
