

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST:** The corporate name is: "Rising Stars Basketball Association, Inc."
- SECOND:** The street address of the initial principal office of the corporation is: 1924 Lake Heritage Circle, Ste. 516, Orlando, FL 32839, and the mailing address is the same.
- THIRD:** The corporation is organized and shall be operated exclusively for charitable, literary or educational purposes, and for such purposes, it may promote, establish, conduct, and maintain activities on its own behalf or it may contribute to or otherwise assist other corporations, organizations and institutions that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 ("Code"), as amended, or corresponding sections of any future federal tax code.
- FOURTH:** The corporation shall not have members.
- FIFTH:** The method of electing Directors will be as set forth in the bylaws.
