**ARTICLES OF INCORPORATION  
OF**

THE UNDERSIGNED, DESIRING TO ORGANIZE A CORPORATION UNDER CHAPTER 617, FLORIDA STATUTES, SET FORTH THE FOLLOWING:

**ARTICLE I**

THE NAME OF THIS CORPORATION SHALL BE A WOMEN'S RESOURCE CENTER OF PALATKA FLORIDA INC. THE ADDRESS OF THE PRINCIPAL OFFICE OF THE CORPORATION AND THE MAILING ADDRESS OF THE CORPORATION IS:  
3 PUTTER LANE PALATKA, FLORIDA 32177.

**ARTICLE II**

THE DURATION OF THE CORPORATION SHALL BE PERPETUAL.

**ARTICLE III**

THE SPECIFIC PURPOSE FOR WHICH THE CORPORATION IS ORGANIZED IS TO PROVIDE FREE COUNSELING, EDUCATION ON PREVENTIVE PREGNANCY, FREE PREGNANCY TESTING, ALONG WITH PARENTING EDUCATION. TO PROVIDE ASSISTANCE TO ANY AND ALL WOMEN WHO ARE PREGNANT.

**ARTICLE IV**

THE STREET ADDRESS OF THE CORPORATION'S INITIAL REGISTERED OFFICE IS 3 PUTTER LANE PALATKA, FLORIDA 32177, AND THE NAME OF THE REGISTERED AGENT AT THAT OFFICE IS BARBARA WRIGHT. A WRITTEN ACCEPTANCE AS REQUIRED IN SECTION 617.0501 F.S. IS ATTACHED HERETO AND MADE A PART HEREOF.

**ARTICLE V**

THE NUMBER OF DIRECTORS CONSTITUTING THE INITIAL BOARD OF DIRECTORS IS FIVE (5), AND THE NAMES OF THE PERSONS WHO SHALL SERVE AS DIRECTORS ARE:

Directors shall be elected as provided in the by-laws.

**ARTICLE VI**

THE DATE AND TIME OF THE COMMENCEMENT OF THE CORPORATE EXISTENCE SHALL BE THE DAY OF THE FILING OF THESE ARTICLES OF INCORPORATION WITH THE SECRETARY OF STATE OF THE STATE OF FLORIDA.
