The undersigned, for the purpose of forming a not-for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

**ARTICLE I: NAME**

The name of the corporation is **IGLESIA DE DIOS EN BROWARD, INC.**  
(Church of God in Broward, Inc.)

**ARTICLE II: PRINCIPAL OFFICE**

The purpose of this corporation is to be a church.

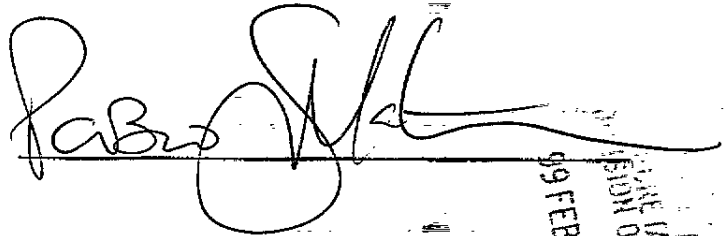
