of

#### ACCESS HOUSING, INC.

We, the undersigned, subscribers to Articles of Amendment, each a natural person competent to contract, hereby associate ourselves together to do an amendment to the Article of Incorporation under the law of the State of Florida.

#### Article VIII (added)

In the event of dissolution, the residual assets of the organization will be turned over to more organizations which themselves are exempt as organizations described in Section 507 (c) (3) and 170 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law or to the Federal, State or Local Government for exclusive public purpose.

Said Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purpose, the making of distributions to organizations that qualify as exempt, organizations under Section 501(c)(3) or the Internal Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
