ARTICLES OF AMENDMENT

TO ARTICLES OF INCORPORATION OF

OPERATION NEW HOPE, INC.

Pursuant to Sections 617.1002 and 617.1006 of the Florida Not for Profit Corporation Act, the Articles of Incorporation of **Operation New Hope, Inc.** (the "Corporation"), are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is Operation New Hope, Inc.

SECOND: Article VI of the Articles of Incorporation is amended to read in its entirety as follows:

"Article VI. Members

The Corporation shall have no members."

THIRD: A new Article XII of the Articles of Incorporation is added to read in its entirety as follows:

"Article XII. Immunity from Civil Liability

To the maximum extent permitted by Florida law, no director or officer of the Board of Directors of the Corporation shall be personally liable for monetary damages to any person for any statement, vote, decision, or failure to take action, regarding the Corporation's management or policy by a director or officer of the Board of Directors of the Corporation."

FOURTH: The foregoing Articles of Amendment were approved and adopted by the Board of Directors of the Corporation on December 9, 2013, and there are no members of the Corporation entitled to vote on the Articles of Amendment.
