ARTICLES OF INCORPORATION

The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation Not For Profit, pursuant to the provisions of the Florida Business Corporation Act.

ARTICLE I - NAME
