We the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida applicable to corporations not-for-profit, under the following proposed charter:

ARTICLE I. NAME

The Name of the corporation shall be **ORLANDO VICTORY UNITED CHURCH OF CHRIST, INC.**, and shall be located at 2200 Silver Star Road, Orlando, Florida 32804.

ARTICLE II. PURPOSES

It is the desire of the Orlando Victory Church to: be an out reach ministry offering to all people an opportunity to receive Christ into their being as the only means by which they can be saved from the guilt of sin and to escape the wrath of God in the last days, thereby calling persons to active discipleship in the church community and the world.

ARTICLE III. MEMBERSHIP

The present membership of Orlando Victory United Church of Christ (unincorporated) and those hereafter admitted to such membership shall constitute the membership of this corporation. Any person who is a member of the Orlando Victory United Church of Christ, Inc. is called a disciple of Christ and is expected to sing, pray, preach, teach and contribute to the purposes of this corporation.

This corporation shall have perpetual existence.

ARTICLE VIII. BY-LAWS

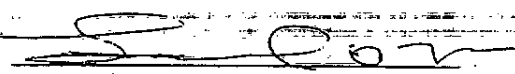
The Constitution and By-Laws may be amended by two-thirds vote of members with full membership status present at an official or annual meeting, providing there is final affirmation from the founding Pastor.

ARTICLE IX. AMENDMENTS

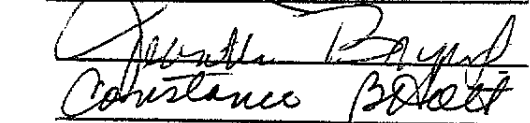
Articles may be amended at any regular or special meeting of the membership of this corporation in the same manner as specified in ARTICLE VIII.

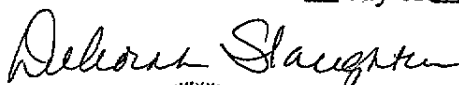
