ARTICLES OF AMENDMENT

FOR

THE SEVEN LIVELY ARTS ALLIANCE OF ST. JOHNS COUNTY, INC.

1. The name of the corporation is THE SEVEN LIVELY ARTS ALLIANCE OF ST. JOHNS COUNTY, INC.

2. By amendment adopted July 28, 1999, ARTICLE II of the Articles of Incorporation is amended to read:

ARTICLE II

The general purpose of the business or businesses to be transacted by this corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida, is to provide a service organization to improve the arts and cultural climate of the St. Johns County community; to facilitate educational programs which further the understanding of, and the participation in, the cultural arts; to help create programs which will benefit St. Johns County school-age children; to facilitate programs in the cultural arts which benefit the physically and mentally challenged; to act as a catalyst to bring organizations together in the furtherance of the arts; to conduct workshops for art organizations; to provide the community at large with a calendar of events promoting the arts and related events; to seek donations of funds and grants to further such purposes; to make and receive contributions as and for organizations that qualify as exempt under §501(c)(3) of the Internal Revenue Code and any corresponding law of the State of Florida.
