*Articles of Incorporation  
of the Foundation for Ritalin Responsibility, Inc.*

The undersigned, a natural person, does hereby form a not-for-profit corporation under the laws of the State of Florida.

ARTICLE I

The name of the not-for-profit corporation is the Foundation for Ritalin Responsibility, Inc.

ARTICLE II

The principal place of business and mailing address of the Foundation for Ritalin Responsibility, Inc. is 4060 Castle Avenue, Spring Hill, FL 34609.

ARTICLE III

The Foundation for Ritalin Responsibility, Inc. is organized to promote the responsible use of medication and may engage in all activities relating to the promotion of the responsible use of medication.

ARTICLE VI

The existence of the corporation is perpetual.

ARTICLE V

The name and address of the initial registered agent of the Foundation for Ritalin Responsibility, Inc. is Altom M. Maglio, Esquire, Altom M. Maglio, P.A., 22 South Tuttle Avenue, Suite 4, Sarasota, Florida 34237.

ARTICLE VI

The corporation shall have three (3) directors initially. The number of directors may be increased or diminished from time to time pursuant to the By-Laws of the corporation, but shall not be less than three nor more than thirteen.

**ARTICLE VII**

The names and addresses of the first Board of Directors of the corporation and the initial Officers who shall hold office for the first year of the corporation's existence or until successors(s) is/are elected and qualified is/are:

ARTICLE X

ARTICLE XI

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the affirmative vote of two-third (2/3) of the Board of Directors.

The initial By-Laws of the corporation shall be adopted by a unanimous vote of the Board of Directors of the Corporation. Thereafter, the By- Laws of the Corporation may be amended, modified or repealed as provided by the By-Laws.

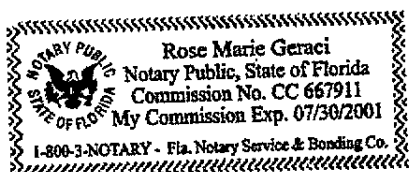
