## ARTICLES OF INCORPORATION OF THE HOSPICE FOUNDATION FOR CARING, INC.

#### ARTICLE I NAME

The name of this corporation is:

#### THE HOSPICE FOUNDATION FOR CARING, INC.

## ARTICLE II NOT FOR PROFIT CORPORATION

The Corporation is a not for profit corporation under Chapter 617, Florida Statutes.

## ARTICLE III DURATION

The Corporation shall have perpetual existence unless dissolved sooner according to law.

## ARTICLE IV PRINCIPAL OFFICE

The principal office of the Corporation will be located at 4266 Sunbeam Road, Jacksonville, Florida 32257 or at such other address as may be determined by the Board of Directors. The mailing address of the Corporation is 4266 Sunbeam Road, Jacksonville, Florida 32257 or at such other address as may be determined by the Board of Directors.

#### ARTICLE V REGISTERED AGENT

The resident agent of the Corporation is Susan Ponder-Stansel, whose address is 4266 Sunbeam Road, Jacksonville, Florida 32257.

#### ARTICLE VI PURPOSES

(a) This Corporation is organized and shall be operated exclusively for charitable, educational, or religious purposes by conducting or supporting activities for the benefit of or to carry out the purposes of Community Hospice of Northeast Florida, Inc. Community Hospice of Northeast Florida, Inc. is a Florida not for profit corporation and an organization exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended (the "Code") as an organization described in Code Section 501(c)(3) and described in Code Section

509(a)(1) or 509(a)(2). It is intended that the Corporation shall have the status of a corporation which is exempt from federal income taxation under Section 501(a) of the Code as an organization described in Section 501(c)(3) of the Code and which is other than a private foundation by reason of being described in Section 509(a)(3) of the Code. These Articles of Incorporation shall be construed accordingly, and all powers and activities of the Corporation shall be limited accordingly.

- (b) The Corporation may not operate to support or benefit any organization other than Community Hospice of Northeast Florida, Inc. However, in the event that Community Hospice of Northeast Florida, Inc. is no longer exempt under Section 501(c)(3) of the Code, the Board of Directors of the Corporation shall act to dissolve the Corporation and to distribute all of the assets of the Corporation in accordance with section (c)3. of this Article VI.
  - (c) Notwithstanding any other provision of these Articles of Incorporation:
  - 1. No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to any Director of the Corporation, Trustee of the Corporation, Officer of the Corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation and payments and distributions may be made in furtherance of the purposes set forth above); and no Director, Trustee, Officer, or any private individual shall be entitled to share in the distributions of any of the corporate assets on dissolution of the Corporation. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.
  - 2. The Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from federal income taxation as described in Code Section 501(c)(3) and in Code Section 509(a)(3) and the Regulations thereunder as they now exist or as they may hereafter be amended or replaced.
  - 3. Upon the dissolution of the Corporation, the assets of the Corporation shall be distributed to Community Hospice of Northeast Florida, Inc. is at that time an organization exempt from income taxation pursuant to Sections 501(a) and 501(c)(3) of the Code. In the event Community Hospice of Northeast Florida, Inc. is not so classified as a tax-exempt organization, or if Community Hospice of Northeast Florida, Inc. is not then in existence, then the assets of the Corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or

organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

4. The Corporation is organized pursuant to the Florida Not For Profit Corporation Act and does not contemplate pecuniary gain or profit and is organized for nonprofit purposes.

#### ARTICLE VII MEMBERSHIP

The Corporation shall have as its sole member Community Hospice of Northeast Florida, Inc., a Florida not for profit corporation.

## ARTICLE VIII DIRECTORS

The Corporation shall at all times have at least three (3) Directors. Directors shall be appointed as provided in the Bylaws of the Corporation. The names and addresses of the initial directors to serve until their successors are qualified and elected pursuant to the Bylaws of the Corporation are:
