**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION  
OF  
THE DELTA AIRCRAFT CORPORATION  
LANDINGS II CONDOMINIUM,  
a Florida Not-for-Profit Corporation**

Pursuant to the provisions of Section 617.1006 of the Florida Business Corporation Act, THE DELTA AIRCRAFT CORPORATION LANDINGS II CONDOMINIUM, a Florida not-for-profit corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation, more specifically, ARTICLE 1 in its entirety, and Section 2.1 of ARTICLE 2:

**ARTICLE 1**

Name

The name of the Corporation shall be:

**THE DELTA AIRCRAFT CORPORATION LANDINGS II OWNERS ASSOCIATION, INC.**, whose address is 2907 West Bay to Bay Boulevard, Tampa, Florida 33629.

**ARTICLE 2**

Purpose

2.1 The purpose for which the Corporation is organized is to provide an entity pursuant to Section 12 of the Condominium Act, which is Chapter 718, Florida Statutes, 1983, for the operation of: **THE DELTA AIRCRAFT CORPORATION'S, THE LANDINGS OF CLEARWATER, A CONDOMINIUM PHASE THREE.**
