ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF PERLE DU LAC CONDOMINIUM ASSOCIATION, INC.

WHEREAS, Perle du Lac Condominium Association, Inc. ("the Association") was created pursuant to Chapter 718, Florida Statutes, for the purpose of operating, administering and maintaining Perle du Lac, a Condominium (the "Condominium") created by the recording of Declaration of Condominium dated on or about August 5, 1999 and recorded at O.R. Book 5843, Page 4848 et seq. of the Public Records of Orange County, Florida (the "Declaration"), and

WHEREAS, Article 9 of the Articles of Incorporation permit the Articles of Incorporation to be amended by not less than eight (8) of the votes cast by the voting members of the Association, and

WHEREAS pursuant to Article 21.4 of the Declaration of Perie du Lac, a Condominium, permits Perie du Lac Condominiums, LLC, the Developer of the Condominium, to exercise so many of the fourteen (14) votes total votes available in the Condominium as have not become appurtenant to the units by conveyance of such units, and

WHEREAS, no units have yet been conveyed by the Developer and the Developer is entitled to exercise all votes available in the Condominium, and

WHEREAS, the Developer has sufficient votes to amend the Articles of Incorporation for all purposes, and

WHEREAS, the Developer desires to specifically provide for the maintenance and upkeep of a certain surface water and stormwater management system serving the Condominium, to restrict the right of the residents to alter the surface water and stormwater management system and to assign and delegate authority and responsibility to the Association to operate, maintain and restrict alteration of the surface water and stormwater management system.

NOW THEREFORE, in consideration of the premises, the Developer by and on behalf of the Association does hereby amend the Articles of Incorporation of Perle du Lac Condominium Association, Inc.

ARTICLE 3 POWERS

The powers of the Association shall include and shall be governed by the following provisions:

- 3.2 <u>Enumeration</u>. The Association shall have all of the powers and duties set forth in Chapter 718, Florida Statutes (the Condominium Act) as it exists on the date of the recording of the Declaration, and all of the powers and duties reasonably necessary to operate the Condominium pursuant to the Declaration, as the Declaration may be amended from time to time, including those powers and duties set forth in these Articles and the Bylaws and those set forth in the Declaration of Condominium, if not inconsistent with the Condominium Act, and including but not limited to the following:
- (m) To levy and collect adequate assessments against members of the Association for the costs of maintenance and operation of the surface water or stormwater management system.
- (n) The Association shall operate, maintain and manage the surface water or stormwater management system(s) in a manner consistent with the St. John's River Water Management District permit number requirements and applicable District rules, and shall assist in the enforcement of the Declaration of Condominium which relate to the surface water or stormwater management system.

ARTICLE 9 AMENDMENTS

Amendments to these Articles of Incorporation shall be proposed and adopted in the following manner.

9.2 Adoption. A resolution for the adoption of a proposed amendment may be proposed either by the board of directors or by the members of the Association. Directors and members not present in person or by proxy at any meeting considering the amendment may express their approval in writing, providing the approval is delivered to the secretary at or prior to the meeting. The approvals must be by not less than eight (8) of the votes cast by the voting members of the Association. The forgoing shall not be construed to prevent such amendments to be considered and approved by a written consent without a meeting, if conducted according to applicable law.

ARTICLE 10 TERM

The term of the Association shall be perpetual. In the event of termination, dissolution or final liquidation of the Association, the responsibility for the operation and maintenance of the surface water or stormwater management system must be transferred to and accepted by an entity which would comply with Section 40C-42.027, F.A.C. and be approved by the St. John's River Water Management District prior to such termination, dissolution or liquidation.
