ARTICLES OF INCORPORATION

OF

MISSION OF LOVE MINISTRIES OF JACKSONVILLE, INCORPORATED

(A Corporation Not For Profit)

We, the undersigned with other persons, are desirous of forming a corporation for charitable and philanthropic purposes, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

**ARTICLE I
(NAME)**

The name of this corporation shall be "Mission of Love Ministries of Jacksonville, Incorporated."

**ARTICLE II
(ADDRESS)**

Mission of Love Ministries of Jacksonville, Incorporated will be located at 6850 Champlain Road, Jacksonville, Florida 32208. The corporation shall be self-sufficient.

**ARTICLE III
(PURPOSES)**

The general purposes for this corporation are exclusively charitable, scientific, health, literary, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954, or the corresponding of any future United States Internal Revenue Law(s).

- To implement and provide comprehensive counseling services, to meet the needs of the general population of Jacksonville and adjacent counties.
 - To implement and provide a Food Service Program. This program will collect and distribute food to needy families and individuals. A neighborhood kitchen will be established to provide meals to the homeless, elderly, disabled, and families who meet the criteria of malnourished or homeless, other risk families and individuals in need of emergency food.
 - To establish a Housing Program to meet the needs of low and moderate income families, the elderly, disabled, and homeless. The housing program will provide an array of housing shelters and group living facilities for the general population of Jacksonville. A housing counseling program and maintenance program will be an integral part of the housing program.
 - To implement and establish an array of educational facilities targeting the needs of under achieving children and youth. Early childhood centers, tutoring and homework assistance, monitoring and counseling will also be an integral part of the education program.
 - Mission of Love Ministries of Jacksonville, Incorporated will work with local, state, and federal government in providing self sufficiency training and job opportunities.
 - Mission of Love Ministries of Jacksonville, Incorporated will establish a Thrift Store to raise funds to help underwrite and support the operation of the goals and programs of the Mission.

ARTICLE IV

MEMBERSHIP

The qualification for members and the manner of their acceptance shall be regulated by the by-laws of this corporation.

ARTICLE V

ADDRESS

The street address of the initial registered office of the Corporation is 6850 Champlain Road, Jacksonville, Florida 32208.

ARTICLE VI

OFFICERS

The business of this corporation shall be managed by the Board of Directors. The Board of Directors shall elect a President, Vice President, Secretary, Treasurer, and others.
