Pursuant to the provisions of Section 617.1006, Florida Statutes, Jubilee/Hometown Station, Inc., a Florida not-for-profit corporation (the "Corporation") whose Articles of Incorporation were filed on July 12, 1999 under Document Number N99000004165, adopts the following Articles of Amendment to its Articles of Incorporation.

ARTICLE I

Article I of the Corporation's Articles of Incorporation is deleted in its entirety and the following is substituted in its stead:

The name of this corporation is Jubilee Okeechobee, Inc. (the "Corporation").

ARTICLE II

The Amendment was adopted by unanimous written consent of the sole member and Board of Directors in accordance with the Corporation's Bylaws on April 10, 2003. The number of votes cast was sufficient for approval.

ARTICLE III

The Amendment shall become effective upon the filing of these Articles of Amendment with the Florida Department of State.
