ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporators of the Corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME

The name of the Corporation is: DOWNTOWN STREET PARTIES, INC.

ARTICLE II - DURATION

The period of duration of the Corporation is perpetual, unless sooner dissolved in accordance with the laws of the State of Florida, or by a court of competent jurisdiction.

ARTICLE III - PURPOSES

The purposes of this Corporation shall be to conduct and promote dances, parties, festivals and events in downtown Eustis, for purposes of promoting business in the downtown Eustis area, and for otherwise conducting any and all lawful business in the State of Florida.

ARTICLE IV - ADDRESS

The initial principal address of the Corporation shall be 32 E. Magnolia, Suite 2, Eustis, Florida 32726, and the initial mailing address shall be Post Office Box 164, Eustis, Florida 32727-164.

ARTICLE V - MEMBERSHIP

The qualifications for membership in the Corporation and the manner of admission of members shall be determined and regulated according to the Bylaws of the Corporation.

ARTICLE VI - DIRECTORS AND OFFICERS

The number, qualifications, and manner of electing directors and officers of the Corporation shall be determined and regulated according to the Bylaws of the Corporation.

ARTICLE VII - INITIAL REGISTERED AGENT

The initial street address in Florida of the initial registered office in this state of the Corporation is 32 E. Magnolia, Suite 2, Eustis, Florida 32726, and the name of the initial registered agent at such address is Charles Rudd.

ARTICLE VIII - NON-PAYMENT OF DIVIDENDS

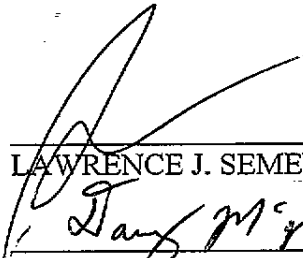
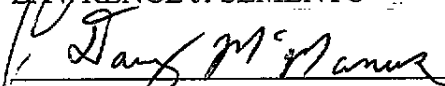
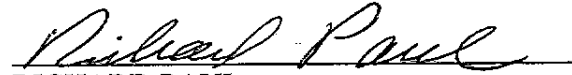
