ARTICLES OF INCORPORATION  
OF

THE WOMEN'S MINISTRY ALLIANCE INC .

I and or we, the undersigned incorporators, for the purpose of forming a corporation under the provisions of chapter 617, Florida Statues, adopt(s) the following Articles of such corporation.

ARTICLES I: The name of this corporation is The Women's Ministry Alliance Inc. 1873 Tigerwood Court , Orlando, Florida 32818.

ARTICLES II: The duration of the corporation shall be perpetual. Unless dissolved according to law.

ARTICLES III: The purpose for which the corporation is organized shall be the transaction of any or all lawful activity for which non-profit corporation may be organized under the Florida General Corporations Act.

Purpose for women and teenage mentoring program:  
To provide counseling for teenagers and women on how to cope with peer pressure, drugs, spouse and child abuse.  
To help parents understand teenagers point of view.  
To provide assistance to teenagers who have quit school to obtain a high school diploma, trade, educational training.

Purpose for community support network: to create a resource network of women who are in the church, business, home, community and political arena, that are willing to work towards the restoration of the local city.

The purpose for The Women's Ministry Alliance Crusades  
To bring people together from all walks of life to deal with issues which affect the success of our community.

To restore families through prayer and work shops  
The crusades will involve restoration of the family and community marches, but will not be limited to these issues only.

Purpose for radio / T.V. ministry will be to talk about problems area among our teens and spiritual enrichment, and the need for community involvement.

Purpose for social, spiritual, and economic development program: To become an organization who develops a city as a total entity which works towards helping all of mankind. such as real estate investments.

Purpose for establishing The Women's Ministry Alliance Chapters is to bring together a group of people to deal with issues that affect the community and nation as a whole.

The foregoing purpose and activities will be interpreted as examples only and not limitations, and nothing there in shall be deemed as prohibiting the non-profit corporation from extending its activities to any related or otherwise permissible lawful non-profit business purpose which may become necessary, or desirable for the furtherance of the non-profit corporate objectives expressed above.

ARTICLES IV: Qualification of members and the manner of their admission will be provided for in the bylaws.
