The articles were adopted/approve by the board of directors on May 23, 2001 members were not needed to vote.

Articles of Amendment of the undersigned, whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Chapter 617, Florida Statutes, do hereby certify:

Articles One: The name of the Corporation shall be The Women's Ministry and Ministerial Alliance, Inc.

Article Two: The place in this state where the principal office of the Corporation is to be located is the City of Orlando, Orange County, 1873 Tigerwood Ct. Orlando Florida 32818.

Article Three: The corporation is organized exclusively for charitable, religious, educational, media, and scientific purposes, including, for such purposes, the making of distributions to organization that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article Four: The board of directors were appointed by the president.

Article Five: No part of the net earning of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof.

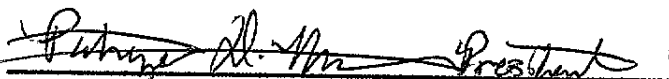
