ARTICLES OF INCORPORATION FOR NEIGHBORHOOD FAMILY CENTERS COALITION, INC.

- I. CORPORATE NAME The name of the Corporation is:

- II. PRINCIPAL OFFICE The NEIGHBORHOOD FAMILY CENTERS COALITION, INC. shall have its principal office(s) at 1002 North Greenwood Avenue, Clearwater, Pinellas County, Florida.
- III. PURPOSE The purpose for which NEIGHBORHOOD FAMILY CENTERS COALITION, INC. is organized are exclusively charitable, scientific, literary, cultural and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
