ARTICLES OF INCORPORATION
OF
CASA JACINTA and FRANCISCO, INC.

The undersigned, for the purpose of forming a nonprofit corporation under Chapter 617, Florida Statutes, does hereby make and adopt the following Articles of Incorporation:

ARTICLE I. Name and Initial Address

The name of this corporation is Casa Jacinta and Francisco, Inc. and the initial address of the Corporation is 7524 San Miguel Way, Naples, Florida, 34109.

ARTICLE II. Not for Profit

The Corporation is a nonprofit corporation under the laws of the State of Florida. The Corporation is not formed for pecuniary profit. No part of the funds of the corporation or any net earnings therefrom shall inure to the benefit of any director, officer of the corporation, or any private person (except that (a) corporate funds may be expended to carry out the charitable purposes of the corporation, and (b) reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes).

Notwithstanding any other provisions of these articles, the corporation shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue law.

No loans shall be made by the Corporation to its trustees or officers. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or against any candidate for public office."

ARTICLE III. Duration

The duration of the Corporation is perpetual.

ARTICLE IV. Purposes

The purposes for which the Corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue law; and

For any other lawful purpose not for pecuniary profit and not prohibited by the laws of the State of Florida or of the United States.

ARTICLE V. Capital Stock

This Corporation shall be nonstock, and no dividends or pecuniary profits shall be declared or paid to the members thereof.

ARTICLE VI. Initial Board of Directors

This Corporation shall have five (5) directors initially. The directors shall be appointed as provided for in the Bylaws of the Corporation. The number of directors may be either increased or diminished from time to time by the Bylaws but shall never be less than five (5). The names and addresses of the initial directors (along with the period of their respective initial terms, commencing upon the date of filing of these articles of incorporation) of the Corporation are:

ARTICLE X. Dissolution

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future Federal tax code, or shall be distributed to the Federal, state, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

ARTICLE XI. Amendment

The Corporation reserves the right to amend or repeal any provisions contained in these articles of incorporation, or any amendment hereto.


