## ARTICLES OF CORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

### ARTICLE I NAME

The name of the corporation shall be: SEMINAIRE THEOLOGIQUE BAPTISTE HAITIEN, Inc.

### ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

### ARTICLE III PURPOSES

The specific purposes for which the corporation is organized are:  
(a) To train pastors and christian lay leaders for haitian churches.  
(b) To minister to spiritual, social and educational needs of the students and members of the the seminary.  
(c) To hold periodic spiritual chapel services as a church ministry.

### ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are appointed is as follows:

- (a) The annual meeting of the directors of the corporation shall be held each year on the first sunday of March at the principal place of business of the corporation, for the purpose of appointing directors by the president and the approval of the board.
